POPULATION RESULT: Broward LGBTQ youth in the dependency system will successfully transition to adulthood.

STORY BEHIND THE CURVE

- Providers were not collecting data until recently on LGBTQ youth
- Fear of discrimination /personal bias
- Ignorance of culturally competent interactions with LGBTQ and knowledge of resources for LGBTQ youth and their families
- LGBTQ youth are lacking at least one significant adult to provide positive support
- Increased mental health concern rates
- Substance use and abuse concerns
- Risky sexual or other behaviors
- Youth in dependency care are not being identified, missing opportunities to provide supports
- Lack of communication, acknowledgement of need for training, identification

BEST IDEAS - WHAT WORKS

- "Guidelines for Managing information related to sexual orientation and gender identity expressions (SOGIE) of children in child welfare systems"
- Sunserve training to non-profits and ongoing technical assistance with providers
- OLC, webinar for LGBTQ CC Training
- Collection and analysis of data (ongoing)
- Youth health and climate survey
- Affirmative linkages and referrals, life coaches
- Mentors, youth groups, affirming therapy

ACTION STEPS

- Review other models /best practices for collecting LGBTQ youth data
- Develop framing guestions, protocols and best practices for collecting, managing and analyzing the data
- Collect baseline data from agencies on LGBTQ policies and practices
- Train therapists in the Childnet system on LGBTQ cultural competency
- Provide Train the trainer on Lambda Legal LGBTQ curriculum
- Requiring LGBTQ cultural competence training for foster parents, housing providers, group homes, Child Advocates, GAL
- Requiring CAs and GALs to link youth to affirming therapy, life coaches, groups ASAP
- In school: Family life and Human sexuality curriculum
- Some schools- HIV testing
- Childnet Predictive Analytics project and baseline data on LGBTQ youth
- Second push for agencies to have their staff complete the LGBTQ Safety Self-Assessment Tool

ACCOMPLISHMENTS

- Developed Agency LGBTQ Safety Self-Assessment tool for agency staff to complete who serve LGBTQ youth in the dependency system
- Received approval for 3 agencies to have their staff complete the LGBTQ Safety Self-Assessment Tool
- Providers have started to collect data
- Completed multiple community trainings
